# Camp Nawakwa

are not supervised by a lifeguard. The Level IV Supervisor (Host, Host Designee, or Keyholder) is the responsible person. Together with on-site supervision, this facility has established a series of safeguards to be followed by all keyholders and their guests.

We are required to notify you of these rules, to ensure that water rescue equipment is in the rack on the dock and that the swimming area is maintained in a sanitary manner. In the interest of your safety and that of your guests, we require you to follow these rules.

Please read the safety rules outlined in this brochure, then sign the Brochure Signature Form in the Registration Book or the Acknowledgment Form on [adk.ny.gov](http://adk.ny.gov), in the Bathing Beach Safety Plan.

Please read the safety rules posted at the swim dock entrance.

If you have any questions, we will be happy to discuss them with you.

**NEVER SWIM ALONE.** Two adults 18 years of age or older, must be present whenever this swimming facility is in use, with one adult in the immediate area and one adult on the swim dock.

This does not include the swimmer.

**THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION.** Children under 18 years of age must be accompanied at the swim dock by a parent or guardian, or similar adult responsible for their safety and behavior.

**IN AN EMERGENCY, NOTIFY THE RESPONSIBLE PERSON WHO WILL CONTACT HELP IMMEDIATELY.** A free telephone is in the safety equipment box. Telephone numbers for the nearest emergency medical service are posted.

Swim only between 7:00 am – 8:00 pm. and swim only in the designated swimming area.

Don't drink alcohol and swim.

Injuries can be prevented and safety is everyone's responsibility. If you notice any problems with the water quality or the absence of safety equipment, please notify us at once.

**YOUR SAFETY IS IMPORTANT TO US. HAVE A SAFE & ENJOYABLE STAY.**

After you have read this brochure, please sign the Brochure Signature Form in the Registration Book. Only guests of this facility who have received and read this Brochure, and signed the Brochure Signature Form, here or on [adkny.org](http://adkny.org), may use the swimming area.
